Godly Play Resumes Sept. 17

Middle School Christian Formation

This year we will continue the practice we began last year of offering Christian formation for youth in grades 6-8 on Sunday mornings from 9:15-10 a.m. in the Youth Lounge. This year we will be using a curriculum focused on our biblical ancestors to go into more depth about the mothers and father of our faith as we continue to explore our place in the larger biblical narrative.

Message from the Rector

The past week was a difficult one. The war-mongering between the U.S.A. and North Korea gave way to the terrible events in Charlottesville, Va., by week's end. But on Sunday, the first day of the new week, many of us joined together at St. John's for worship. We heard the story of Joseph's brothers trying to destroy Joseph's dreams ("let us kill this dreamer and see what becomes of his dreams"). We heard Paul remind the Christian community in Rome that God makes no distinction between people and that "the same Lord is Lord of all." We heard the story of Jesus pulling Peter out of the sea in the midst of a storm. Reflecting on this last story, Hilary reminded us that while "fear lives in the head, courage lives in the heart. And love," she said, "is all around us." Michael Bennett, Greg Buzzard, Gabe Mason and Sven Schreiber offered God and the congregation beautiful music, and we raised our voices in song declaring that "in Christ there is no east or west." We prayed together, we confessed and were absolved together, and then we joined together at the Lord's table to once again be and become the body of Christ.

This is what worship does for us. This is what worship does to us. It keeps us focused on the story of God's people as it reminds us that we, too, are a part of God's people. It keeps us focused on building God's Kingdom as it reminds us that the Kingdom has come near. It reminds us that we have "sinned in thought, word and deed" and that God has forgiven all our sins through Jesus. Our worship reminds us that though we are many, we are one in the body of Christ. Our worship comforts us in the midst of our fears, it articulates the hope of the Christian Gospel, and it draws our hearts closer and closer to God.

Sometimes in the busy-ness of my work as a priest, I lose touch with the point of that work. Sometimes in the midst of preparing bulletins and sermons — or worse yet, in the midst of planning capital campaigns — I lose touch with the meaning and power of our worship. I was complaining to a friend recently about the cost of the projects we have planned for the capital campaign — about the cost of the organ and the many repairs. I wondered aloud if what we are planning makes a difference, if it matters to the Kingdom of God and to our mission as the Body of Christ. The friend — an evangelical pastor who is used to guitars and drum kits and very little that resembles our traditional liturgy — looked around and said, "Your whole architecture is worship." Everything is focused, he went on to say, on connecting people to God and one another through that worship. The organ and the repairs are a part of that mission and ministry. It's all a part of the most important thing you do, he said.

I've been thinking about that more and more as we get closer to formally launching our campaign. Why are we doing this? What is it for? What does it all mean? Does it somehow contribute to God's Kingdom? The answer, I believe, is yes, provided that we always see our worship for what it is. Our worship is not a performance for the congregation or for random people who might show up on a Sunday. It isn't a concert with some commentary thrown in. Our worship is meant to draw us closer to God and to remind us of who we are, what we are, and whose we are. Our worship is meant to draw us closer to God's own mission in the world—the reconciliation of all people with God and one another through Christ. Our campaign is important, our campaign contributes to our mission and ministry — to God's mission in the world — if it does that.

I hope you never take for granted what we do on Sunday mornings (and throughout the week as well). It is important work. That work is even more important when the times are difficult — when fear and anger and hatred seem to be winning the day. We don't know what will happen in the wider world or even in our local community, but we know that we can always connect and reconnect with God and with our sisters and brothers in Christ through worship. Update on Parking at St. John's

I have yet to find it in the archives, but I'm certain that in the 1880s, a St. John's vestry member thwarted a proposed parking lot saying, "This horseless carriage thing is a passing phase." Now that the old *Journal & Courier* buildings are being turned into apartments, we will lose the use of the parking lot across the street from the church on Sixth and Ferry Streets. The good news is that we have permission to continue using the lot most Sundays until next summer. In addition, we now have permission to park in several other lots near the church on Sunday mornings. Parishioners may park at **Dr. Yocum's**



office and at Tricoci University, both of which are on Ferry Street just east of the church. Parishioners may park at Mulhaupts on Ferry Street just west of the church. In addition, we may also park at Wintek, which has a large parking lot on Sixth Street north of the church (please note, the Wintek lot is *not* the TAF lot or the lot owned by First Christian Church). Street side parking is available on each of the streets surrounding St. John's. Because most businesses are not open on Sunday morning, there should also be available parking on Main and Sixth Streets south of Ferry. We are looking to get permission to use other spots as well and may try have signs placed to direct visitors, etc. We will continue to block off parking spots nearest the church on Sunday mornings for those who have mobility issues. You *do not need* a handicap sticker to use one of those spots (unless they are also marked as handicapped spots). For those of you who are able to walk a few blocks, please consider parking in one of the more distant lots.

While it is great to see the growth and expansion of downtown Lafayette, it does come with costs. Parking will continue to be an issue for the foreseeable future. If you have any suggestions or solutions, don't hesitate to get in touch with me. If the church can help provide transportation, let us know that also. — Bradley Pace, bradleypace@stjohns-laf.org

Habitat for Humanity Apostle's Build

This fall, St. John's is once again participating with 10 other area churches to build a house as part of the Apostle's Build with Habitat for Humanity of Lafayette. Our commitment to this build includes fundraising at least \$3,000 and getting a crew(s) together to help build.

Currently, the following dates have been identified for assisting with the build: **8 a.m.-noon Friday, Sept. 8, and 8 a.m.-noon Saturday, Sept. 16**. The Friday time is an opportunity to help with the framing, which is putting up the walls. It's a time when you can easily see progress throughout the day. Saturday is scheduled as having volunteers work on siding and professionals getting started on mechanicals.

There are sign-up sheets in the Commons, on the community bulletin board, along with a flyer presenting information about the family who will move into this house.

If you are interested in helping and your skills are more in the painting space, we can add another date a bit later for that type of work. Just let me know if you are interested in that work.

Finally, we still need to raise a little over \$1,000 to make our commitment to Habitat. So remember, even if you don't feel comfortable with the actual construction process, you have a role to play in helping support the dream of home ownership in our community. — Amy Van Epps, amysvanepps@gmail.com

From the Vestry: Meeting Summary, August 16, 2017

- Bradley indicated that the several people had agreed to be a part of the capital campaign leadership. Rachel
 Ravellette and Charlie Shook will be co-chairs. Emily Umulis has agreed to serve in the capacity of campaign
 coordinator. This is a paid position and one St. John's used in the 1995 campaign. (please see the Vestry minutes
 when published for a complete list of names.) The planned completion date for the campaign is Nov. 22, 2017.
- Vestry members will likely serve as gift workers and get training, most likely on Sept. 27, 2017. There will be a capital campaign kickoff event on Oct. 21, 2017. George Moore and Kristine Holdveldt are coordinating this event.
- Bradley detailed what the campaign construction loan entailed. This would be a three-year loan. It would help cover construction costs as the pledges come in. Bradley said that St. John's would need to provide collateral and the investment committee and fund manager agrees the endowment fund could be used for this. No money needs to be liquefied for this to happen. In accordance with the recommendation of the Investment committee, Bradley moved that the Vestry amend the endowment policy to allow St. John's to use a portion of the endowment to secure a construction loan up to \$600,000.. Bradley indicated that the loan would be a line of credit loan and St. John's would not need to access the entire amount. The motion passed. The vestry also approved a motion for St. John's to actually seek out a loan with the best terms with a reputable (hopefully local) lender.
- After lengthy discussion the Vestry voted to approve the total campaign amount, which is \$641,510.57.
- Bradley reported that the new freezers are in and working in the food pantry.
- The new air conditioner has been installed and is working.
- Convention delegates have been approved.
- Bradley discussed parking and indicated St. John's has been given the OK to park in some additional downtown lots. A
 map will be included with the September Eagle.

- Bradley reported that Peter Cooper has resigned from the Vestry. The Vestry received his resignation.
- There was discussion regarding Vestry elections and possible candidates. Several Vestry members said they would talk to people about serving.
- Bradley reported that there have been some informal discussions with Food Finders about the pantry and ways St. John's could work with Food Finders.
