

# From the Rector

During our discussion about the Memorial Garden a few weeks ago, someone asked if I could share resources for helping those who come to St. John's (or those folks we encounter out in the community) looking for emergency assistance. The key is to make sure that we are, in the words of Jesus, as innocent as doves and as wise and serpents. The last thing most of us ever want to do is actually hurt those we want to help. But many of the folks who are homeless in Greater Lafayette are homeless in part because of addiction issues (local advocates estimate 75 percent or so). Handing out money or other resources can actually contribute to their problems and make things worse. And yet, it is critical that we show compassion to those who are already hurting. How can we do this in an effective way?

Lafayette Transitional Housing has created a "Decision Tree" for local churches that works primarily to connect people in need with local services. LTHC, for instance, provides rapid

If you determine that the household should be engaged in case management but is not currently connected, try to facilitate engagement with a case management provider in Lafayette. In general, individuals or families with housing-related struggles should contact Lafayette Transitional Housing or Lafayette Urban Ministry.

Households with children who do not have a housing-related problem should contact Bauer Family Resources. Any issues related to active domestic violence should be referred to the YWCA's Domestic Violence Intervention and Prevention Program.

re-housing and other resources for those folks facing homelessness. They provide a wide range of services, including case management. Those folks experiencing recurrent episodes of need or experiencing significant barriers such as substance abuse, mental illness, prolonged lack of income or prospects of income, domestic violence or chronic homelessness should be engaged in case management services. Contacting these agencies and advocating for the person seeking assistance can be very helpful. If the person is already connected to case management through LTHC or another agency, you can ask their permission to contact the case manager about the best ways to help. Be sure to be consistent with the input of the agency, unless there is an overwhelmingly compelling reason not to be.

LTHC offers the following advice about helping:

- 1. What if I want to personally help out financially?
- Go through the case manager that the participant is working with.
- Do not offer any assistance that might create some level of dependency.
- · Consider "matching" assistance.
- · Consider realistic incentives.
- Consider offering a partial contribution of real goods (for example, "when you move into your new place, I have a coffee table and lamp you can have.").
- Consider offering things anonymously.
- · Remember the difference between being responsible to and responsible for.
- 2. What if, after I refer them to a service, they respond "I've tried them, and they won't help me"?

- Be wary of this response it may mask the reality that the person never actually contacted the service, is going off of what others have said about their services, or is trying to get direct help from you.
- Clarifying questions may help, such as "When did you speak with someone there? Whom did
  you talk to? Did they explain why they couldn't help you?" These questions will help you verify
  that the person is contacting the correct agency as well as give you some data to help them
  with problem-solving.
- · Eventually you may have to advocate for the person, asking "Should we talk to them together?"
- Trust the resources being offered by the community unless you witness something first hand that causes you to believe otherwise.
- 3. How far should I go in advocating for someone needing services?
- Sometimes persons in crisis are not able to advocate for themselves. Common reasons include:
  - not able to say same words that agency needs to hear to make proper connection
  - not able to understand fully what agency is offering
  - information overload
  - "too many choices" difficult to decide which path to take
  - operating with old information program requirements change and people's circumstances change since they last inquired into services
- When advocating for someone, there is value in working directly with the person and other times there is value in doing that advocacy behind the scenes. In general, it is good to advocate with the person if you believe there is an issue of clarity or in trying to advocate for the service provider's point of view. In general, it is best to advocate correctively with the agency without the person present. After those efforts fail, advocating correctively with the person may be your only recourse. As much as possible, you want to align your advocacy with the agency, since this is the long-term relationship that you are trying to foster for the person.

# Service of Holy Eucharist & Healing

The ministry of Jesus invites us to new life in God and with each other. In the laying on of hands and anointing we proclaim the Good News that God desires us to be healthy and one in the body of Christ. You are invited to come forward, to offer yourself, whatever your sickness of spirit, mind, or body, and ask for healing and wholeness in the Name of the holy and undivided Trinity.

The invitation to healing prayer from Enriching Our Worship II

Most Sundays, St. John's offers healing prayer in the Chapel of the Resurrection at the end of Communion. Each Tuesday at noon, St. John's hosts a service of Healing Prayer and Eucharist in the Chapel of the Resurrection. Healing prayer (also known as unction or "ministration to the sick" in the Book of Common Prayer) has a long tradition in the Church. The person who receives healing prayer is anointed by special oil blessed by the Bishop or a priest. A minister anoints the person requesting prayer and lays hands on her invoking God to bring about healing and wholeness.

On Sunday, Oct. 14, at both the 8 and 10:15 a.m. services, we will include a time of healing prayer in our services. After the sermon, the presider will bless oil to be used for anointing during those services as well as during services throughout the year at St. John's. Special prayers of healing will be said by the congregation. All are invited to come forward for anointing and for a time of prayer. — *Bradley Pace*, <code>bradleypace@stjohns-laf.org</code>

## The St. John's Vestry Seeks New Members

The St. John's Vestry is currently soliciting new members to join the Vestry in 2019. Vestry terms are for three years. Terms begin once the annual meeting is completed. The Canons of the Episcopal Church and of the Diocese of Indianapolis and our parish's own bylaws set the following minimal criteria for membership on the St. John's Vestry:

- 1. Shall be a member in good standing of the parish.
- 2. Shall be a qualified elector.
- 3. In addition, the bylaws state that at least two-thirds of the Vestry must be confirmed adults in good standing.

Vestry service, however, is much more than these minimal, canonical requirements suggest. Our ministry focuses on the work of God as it is lived out in this church community. We commit ourselves to a reasonable understanding of the church's structure, management and finances. We commit to be leaders in attending the worship and fellowship of the church; in supporting the church through our financial stewardship; through outreach, service and evangelism; and through supporting the mission and ministry of the church in other ways. We commit to be leaders in prayer and in the study of Scripture. And we commit ourselves to living out the Gospel in our daily lives. We recognize that our ministry is ultimately and fundamentally about God. It is God who brings us together and sets us apart. After all, we Worship God, we Share God's love and our lives, and we Make Christ Known because in Jesus Christ we find the fullest expression of who God is and what God is doing in the world. # A Wonderful Gift to the Ministry of St. John's

Longtime member Anne Lommel died this spring after a long illness. A dedicated member of St. John's, she had served the church in a number of capacities. When I met her, she helped with financial records in the office. She mentioned to me in passing that she had written all the big checks for the last capital campaign in the 1990s. I was surprised by the nonchalant way she just dropped the fact that she had bankrolled a \$2 million campaign. Turns out that she was the treasurer and had literally written the checks for the campaign. She may have also supported the campaign, but that's not what she meant.

Anne supported St. John's with her time, talent and treasure. She also left a last generous gift to the church — a gift of nearly \$250,000 from her estate. She asked that the bequest be added to a portion of the endowment that will go to support our future ministry. She did leave open the possibility that the leadership may use the money in other ways, and in the short term, the Vestry has decided to pay down the construction loan for the capital campaign. As contributions come in, we will replenish the portion of her bequest that was used. This will save several thousand dollars in interest.

This was a very generous gift from Anne. She left this gift because St. John's and our ministries meant a great deal to her. I would encourage you to consider including St. John's in your estate planning. The future of our ministry is strengthened substantially by these gifts.
