
St. John's Reopening Plan: An overview

I know that many of you are anxious about when we will be able to gather again for in-person worship. At this point, I can only say that the leadership is working on a reopening plan that prioritizes the health and safety of those who might gather for worship. In May, the Bishop released guidelines for reopening, and, in response, I appointed a task force to create our own, local plan (you can read her revised guidelines in their entirety at indydio.org/revised-diocesan-reopening-guidelines/). I have been very grateful to Michael Bennett, Anna Burman, Gretchen Freese, Bruce Johnson, Maggie McClure, Tom Melville, Mary Anne Robinson, Annie Schreiber and Cynthia Stauffacher for their insight and counsel as we work together to create this plan.

In the meantime, I can say that it is likely to be several more weeks before we consider gathering for in-person worship. The Bishop's directive makes our timeline dependent on certain metrics that are not under our control. In order to gather for in-person worship:

- The number of COVID-19 cases in Tippecanoe County must have decreased for 14 days or have held steady with a mere handful of cases. As of this writing, the number of new cases in Tippecanoe County continues to bounce up and down (with 20 new cases being reported June 19).
- The infection rate (known as the "R-naught" number) must be less than 1.0, which means that on average in the community, each infected person is infecting less than one other person and the total number of current cases is shrinking. The current rate for Tippecanoe County is 1.02 (compared to a statewide rate of 0.91). This means the virus continues to spread in our community.
- The positive test rate must be less than 10 percent, preferably closer to 3 percent or less. The positive test rate measures how many people test positive compared to all who were tested in a given period of time and indicates whether testing is widespread enough to detect most new cases. At present, the positive test rate for Tippecanoe County is 5.77 percent.

According to the Bishop's directive, once we meet these metrics, we may petition the Diocese to have in-person gatherings of no more than 25 people. At present, there are no plans to fully reopen. To be honest, the additional guidelines (masks will be required for all participants; the Eucharist is highly discouraged for the time being; coffee hour, physical contact of any kind, and singing are all prohibited; high-touch surfaces must be cleaned between services; etc.) will make gathering difficult generally and may make worship strange and unfamiliar. To get a sense of what worship will be like under these guidelines, see a recent blogpost by the Rev. While his description doesn't fit our situation exactly, it does offer some sense of the impact COVID-19 will have on our worship for the time being. (continued on page 2)

While we continue to work on details for regathering, the task force has determined to use the summer months (June, July and August in particular) to gather additional information about the scope of COVID-19 infections in Tippecanoe County and to create local guidelines that adhere strictly to the Bishop's directives. As such, we are considering a number of issues around re-gathering: adjusting the worship schedule or adding additional services, cleaning protocols, reservations and registration for contact tracing and ways to communicate these guidelines.

The task force hopes to have a plan ("we plan to have a plan") no sooner than the end of July. Once that plan has been approved by the vestry, we will hold a Zoom meeting town hall to discuss with the congregation.

Again, I know that many of you are looking forward to returning to church and to a sense of normalcy in your lives. I wish I had better news or could offer a more optimistic appraisal of things. But for the time being, we must continue to protect one another and to love our neighbor by gathering in other ways. As we continue our work together, I ask that you continue praying for the members of St. John's and for all who find community here.

St. John's Financial Report

In May we received the Paycheck Protection Program loan proceeds of \$50,300, which were used to support payroll and utilities. We also received a grant from the Center for Congregations of \$4,765, which we used to purchase technology for online/virtual worship. These show in the non-operating income/grants section of the income statement. Excluding those transactions, we broke even for the month of May.

When we applied for the Paycheck Protection loan, our average monthly payroll expenses for 2019 were \$20,146, and we requested 2.5 months' payroll, or \$50,300. During the eight-week period, payroll totaled \$39,400. Adding utilities for May and June, we will have used about \$40,800 of the loan amount. With that total, we would be required to repay about \$9,500 of the \$50,300 loan. Congress recently passed the Paycheck Protection Program Flexibility Act that extended the forgiveness period from eight weeks to 24 weeks. We may qualify for that extension.

Pledge income has been steady during the months of April and May at \$28,500 each month (compared to \$32,200 for March, \$32,100 for February and \$24,400 for January). YTD pledge income is 39 percent of the budget for the first 42 percent of the year. Other income was down due to spring events being canceled and only 6 percent of budgeted dividend income being taken. But our expenses have also been lower — 34 percent of the budgeted amount for 42 percent of the year. Because of the PPP loan, tech grant and continues pledges, the year-to-date balance is \$34,100 to the positive.

I'm Still Here: Black Dignity in a World Made for Whiteness, by Austin Channing Brown

From the Amazon.com Review – Austin Channing Brown’s first encounter with a racialized America came at age 7, when she discovered her parents named her Austin to deceive future employers into thinking she was a white man. Growing up in majority-white schools and churches, Austin writes, “I had to learn what it means to love blackness,” a journey that led to a lifetime spent navigating America’s racial divide as a writer, speaker and expert helping organizations practice genuine inclusion.

In a time when nearly every institution (schools, churches, universities, businesses) claims to value diversity in its mission statement, Austin writes in breathtaking detail about her journey to self-worth and the pitfalls that kill our attempts at racial justice. Her stories bear witness to the complexity of America’s social fabric — from Black Cleveland neighborhoods to private schools in the middle-class suburbs, from prison walls to the boardrooms at majority-white organizations.

For readers who have engaged with America’s legacy on race through the writing of Ta-Nehisi Coates and Michael Eric Dyson, *I’m Still Here* is an illuminating look at how white, middle-class Evangelicalism has participated in an era of rising racial hostility, inviting the reader to confront apathy, recognize God’s ongoing work in the world and discover how blackness — if we let it — can save us all.
