



## Meditating and Moving: A Quiet Day Opportunity Saturday, March 8, 2014 | 10am – 2pm

Join us for a Lenten quiet day opportunity of common practice. We will begin with worship in the Chapel followed by an introduction to Christian Meditation. Hilary Cooke, our Associate Rector, and an experienced meditation practitioner, will introduce us to the work of the World Community for Christian Meditation <a href="http://www.wccm.org/">http://www.wccm.org/</a>>.



After that sedentary practice, Courtenay Murakowski will introduce us to prayer walking. Prayer walking is the practice of praying on location, a type of intercessory prayer that involves walking to or near a particular place while praying. Some people believe that being close to a location allows them to "pray nearer to pray clearer." Prayer walks are taken by individuals, groups, and even whole churches. If the weather is good and our health permits, we will pray around the St. John's neighborhood; if not, we will prayer walk around our church.

Following our walk, we will enjoy fellowship with a light lunch. You may bring a dish, or not!

After lunch, Amy Paget will introduce Metta (Loving Kindness) Meditation, a Buddhist practice to which she was introduced by her spiritual director. Metta meditation has brought Amy much joy and she sees it as an



intentional practice focused on the golden rule and attending to the second of the greatest commandments: "Love the Lord your God with all your heart and with all your soul and with all your mind.' This is the first and greatest commandment. And the second is like it: 'Love your neighbor as yourself.' All the Law and the Prophets hang on these two commandments. [Matthew 22:36-38]

Include future Quiet Days on your calendar and watch for our sign-up sheets in the Commons. We will be celebrating World Labyrinth Day again this year on Saturday, May 3, from 10-4 pm. We expect to be joined by Trinity UMC parishioners and to include walks at their outdoor labyrinth built last fall.

## From the Rector

You may know the old joke: How many Episcopalians does it take to change a light bulb? Change? CHANGE?!? But my grandmother donated that light bulb ("to the glory of God and in thanksgiving for..."). It's a bit lame, but still worthy of a chuckle.

The fact is, very few people like change. I read somewhere a few years back that only 15% of people actually like change. Still, it seems that the aversion to change is more acute in church, and the light bulb joke would apply to pretty much any denomination. In 30 years, mega-church parishioners will have similar jokes about overhead projectors, I guarantee it.

Of course change is a part of life. The teacher in the book of Ecclesiastes puts this in such beautiful, poetic language:

For everything there is a season, and a time for every matter under heaven: a time to be born, and a time to die; a time to plant, and a time to pluck up what is planted; a time to kill, and a time to heal; a time to break down, and a time to build up; a time to weep, and a time to laugh; a time to mourn, and a time to dance; a time to throw away stones, and a time to gather stones together; a time to embrace, and a time to refrain from embracing; a time to seek, and a time to lose; a time to keep, and a time to throw away; a time to tear, and a time to sew; a time to keep silence, and a time to speak; a time to love, and a time to hate; a time for war, and a time for peace. (Ecclesiastes 3:1-8)

If you don't know that version, you may remember Pete Seeger's version ("To everything, turn, turn, turn, ..."). Either way, it's true. And so often, change can be really painful. Cherished old ways seem to slip away. Beloved traditions die. Friends and loved ones die. Things are just not the way they used to be.

But the fact that most of us struggle with change betrays the fact that change can be good. New things are born, they grow, they flourish. There's energy and fresh expression. Change brings pain, but it is also an opportunity for joy.

I say all of this because I know that my very presence as your new rector at St. John's ("New"? Has it been a whole year?) has meant change. My leadership style, my personality, my age, my family, my priorities, my sense of humor, my theology, my experiences, my understanding of the church, etc. all bring change. Even if I were a near clone of my predecessors, things would still seem different because the world has changed around us. The people coming to St. John's have changed. Each of you will have changed from the time you first joined the St. John's community. New people are showing up. There are a lots of young families coming, more kids, a hum of noise and energy. This is change. And that change will likely bring a mix of joy and pain.

The conventional wisdom is that a new rector shouldn't change much in the first year. And even though I've been with you a whole year, I don't have any magnificent plans to change things at St. John's. We have beautiful worship and music. We do good things in the community. The institution is in very good shape (as you will see from reading our Annual Report). St. John's is a vibrant, strong church. I think we're growing, and I see every reason for that growth and energy to continue.

I'll change some things here and there. The vestry may turn to some new priorities. We'll continue to update our communication. But growth and energy alone bring about change. And that change will likely bring a mix of joy and pain.

So I want to reiterate what I have said ever since I joined you. If you ever want to discuss something with me, please make an appointment so we can talk. Come and tell me about the joys of this community. Come and tell me about St. John's heritage and hallowed traditions. Come and tell me about your memories of St. John's or of the church of your childhood. Come and tell me where change has been painful. I want to know. You may want to talk about it.

I continue to be so grateful for the opportunity to serve God with you here in Lafayette at St. John's. As I said, St. John's is a strong, vibrant church. You are faithful people, and I thank God for your witness and ministry.

## Schedule Changes

Thanks to the generous support of the people of St. John's, the Vestry, and Bradley, and assuming that the 2014 budget passes at the Annual Meeting on February 2, my hours at St. John's will increase from 12 hours/week to half-time. ## **February Book Group**

February is African American History Month, and the Book Discussions group at St. John's will again observe this theme. In 2013, we explored two accounts of growing up biracial (Black/White) in the United States – one autobiographical, the other fictional. This year we explore the experiences of a world-renown man, Barack Obama. Specifically, we will discuss his 1995 memoir, Dreams from My Father.

The memoir covers the history as he knew it of his grandparents and parents on both sides – White Kansans and Black Kenyans. Obama then recollects his experiences in Hawaii, Indonesia, California, New York City, Chicago, and a trip to Kenya to learn of his father's family history. He finishes his story as he heads off to Harvard Law School at age 27.

A helpful companion book to Dreams is a biography of Obama that covers the same time period – Barack Obama: The Story (2012) by David Maraniss. He reminds us that Dreams from My Father "falls into the realm of literature and memoir, not history and autobiography, and should not be read as a rigorously factual account." Obama reflects what he was told about his history, which is sometimes different from what happened. Also, for the sake of brevity and privacy, he has changed names of some people and blended others into a single person. The theme is how, with his improbable history, he thinks about race and culture and what this means for him.

## **Episcopal Women's Ministries**

The goal was met! In August 2013, the EWM Council challenged the women in our diocese to raise money for the Craine House Fall Capital Campaign. Craine House is a non-profit organization in its 36th year as a unique, court-appointed alternative sentencing, work-release program dedicated to serving non-violent female offender with pre-school children and from Indiana. At Craine House women and their children live with dignity in a safe, structured, and supportive environment. This House was begun by Bishop John P. Craine and The Rev. Jackie Means of our diocese. EWM voted to match monies raised (up to \$5,000) by the end of the campaign (December 31, 2013). The challenge was successful, and together over \$10,000 was contributed for Craine House. A BIG "Thank You" to all who participated.


## **LUM Good Samaritan Fun Follies**


